### ORDER:

In the Government Order first read above, the estimate of vacancy for the post of Assistant Executive Engineers (Civil) in the Tamil Nadu

Engineering Service, Branch –I, Public Works for the year 2013-2014 had been fixed as 169 Nos.

- 2. In the Government Order second read above, orders have been issued approving the temporary lists of Assistant Engineers / Junior Engineers fit for promotion / appointment for the post of Assistant Executive Engineers(Civil) for the year 2013-2014 consisting of 127 Nos. of Assistant Engineers and 41 Nos. of Junior Engineers and in the Government Order third read above, amendment was issued to include one number of Junior Engineer at SI. No. 42 and they were subsequently promoted / appointed as Assistant Executive Engineers (Civil) in Public Works Department in Government Order fourth read above.
- 3. In the Government Orders fifth and sixth read above, orders have been issued for restoration of seniority in respect of 2 Nos. of Junior Engineers in the post of Assistant Executive Engineer (Civil) in the respective place.
- 4. Thiru. S. Manikandan and 8 others who were selected by Tamil Nadu Public Service Commission in the 1997-1998 batch, have filed Writ Petition No. 46868 of 2006 before the High Court of Madras with a prayer to direct the Tamil Nadu Public Service Commission to revise their seniority in the post of Assistant Engineer in Public Works Department as per the practice followed earlier to 1996 in assigning the ranks which was dismissed by Common Order dated 18.10.2012 on the sole ground that the petitioners were guilty of delay and laches.
- 5. Aggrieved by the above order, the Writ Petitioners have filed a Writ Appeal. The Division Bench of Madras High Court in its Common Order dated 31.3.2015 passed in W.A. No. 2705, 2730, 2731 of 2012, 2394 and 1033 of 2013 allowed the Writ Appeals and directed the official respondents to take the rank assigned by the Service Commission to the selectees, as the basis for fixation of seniority and issue appropriate orders within a period of 4 weeks from the date of receipt of a copy of the order.
- 6. The Tamil Nadu Public Service Commission, preferred SLP (Civil) No. 22094 22098 of 2015 (SLP (C) No. 2886 of 2016) against the above order of the Division Bench dated 31.3.2015 in the Supreme Court of India. The Hon'ble Supreme Court in its Order dated 22.1.2016 has held that, "after the emergence of the judgment in Bimlesh Tanwar, the fundamental principle relating to drawl of seniority list was that it should be based on merit list of selection and that the list drawn based on roster point can have no application for the purpose of seniority list. As the said fundamental principle was applied by the High Court in passing the impugned judgment, we do not find any merit in these special leave petitions. The special leave petitions were dismissed".

- The Tamil Nadu Public Service Commission has preferred Review Petition on the above orders before the Supreme Court of India and these Review Petitions were also dismissed by the Hon'ble Supreme Court of India on 25.8,2020.
- 8. Certain contempt petitions were filed by the selectees, who were aggrieved by non revision of the seniority list in the Supreme Court of India. The Hon'ble Supreme Court of India in its order seventh read above in Contempt Petition Civil Appeal No.4954 of 2016, dated 01.10.2021 has passed the following orders:-
  - "28. We therefore direct the respondents to revise and publish the seniority list of the selectees, who were selected in the selection process conducted in pursuance of the notification issued by TNPSC dated 10th September 1999, strictly on the basis of the merit determined by it in the selection process and not on the basis of the roster point. The same shall be done within a period of 12 weeks from the date of this order".
- 9. In compliance of the above Orders of the Hon'ble Supreme Court, the Secretary, Tamil Nadu Public Service Commission in the D.O. letter eighth read above, has furnished the revised seniority list of candidates as per merit ordered by the Hon'ble Supreme Court of India, recruited for the posts of Assistant Engineer(Civil) in Public Works Department during 1997-1998, 1997-1999 and 2006-2007, to the Engineer-in-Chief, Water Resources Department and Chief Engineer (General), Public Works Department, Chennai.
- 10. The Engineer-in-Chief, Water Resources Department and Chief Engineer (General), Public Works Department in his letter ninth read above, has sent proposal for revision of seniority of Assistant Engineers selected in the 1997-1998 batch included in the temporary lists of Assistant Engineers / Junior Engineers fit for promotion / appointment as Assistant Executive Engineers(Civil) approved during the year 2013-2014.
- 11. The Government after careful consideration of the proposal of the Engineer-in-Chief, Water Resources Department and Chief Engineer (General), Public Works Department and decided to accept it. Accordingly, in supersession of the orders issued in the Government Order second, fifth and sixth read above, the Government revise the temporary lists of Assistant Engineers / Junior Engineers fit for promotion / appointment as Assistant Executive Engineers(Civil) approved during the year 2013-2014 as below:-
