ORDER:

In the Government Order first read above, guidelines have been issued for the vertical separation of the Department into Public Works Department and Water Resources Department. Rajamohan, Chief Engineer, Technical Education Circle, Public Works Department, Chennai and creation of one post of Special Secretary to Government, Public Works Department in the cadre of Chief Engineer in the Government Order second read above and creation of one post of Chief Engineer, Chennai Region, Chennai in Public Works Department in the Government Order third read above, the Government have approved the Estimate of Vacancy for the post of Chief Engineer, Public Works Department for the year 2022-2023 as "3" in the Government Order fourth read above.
- 3. The Government after careful consideration of the proposal of the Engineer-Chief and Chief Engineer (General), Public Works Department, Chennai, sent in the letter sixth read above have decided to accept it. The Government hereby accord temporary promotion to the following Superintending Engineers in Public Works Department under Section 47(1) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 and posting of the officers as detailed below:-
