ORDER:

In the Government Order first read above among others, Thiru. R. Baskar, Executive Engineer(Civil) was transferred and posted as Deputy Superintending Engineer (Civil), Water Resources Department, Pennaiyar Basin Circle, Thiruvannamalai. But he has not joined duty and proceeded on Earned Leave and Unearned Leave on Medical Certificate for more than 7 months.

2. As per Rule 9-A(i) under Appendix-I in Annexure-II-Part-I under Fundamental Rule 74, wherein it has been prescribed that before leave is sanctioned, the recommendations of Medical Committee shall be compulsorily obtained. Hence, Engineer-in-Chief, Water Resources Department and Chief Engineer (General), Public Works Department, Chennai was requested to state whether Thiru. R. Baskar, Executive Engineer, Water Resources Department has been referred to the Medical Committee for its recommendation and to send a report to the Government.

3. Subsequently, the Engineer-in-Chief, Water Resources Department and Chief Engineer (General), Public Works Department, Chennai in his letters fourth read above, has furnished the report of Medical Board in respect of Thiru. R. Baskar, Executive Engineer (Civil). The Medical Board, Mahatma Gandhi Memorial Government Hospital, Trichy in its report 3rd read above, have examined the individual and found that he has recovered from his illness. The Medical Board regularizes the leave period from 1.2.2021 to 10.3.2021 as leave on Medical Grounds as per the Medical Certificate issued by the qualified Medical Officer is genuine since the evaluation of the report reveals the illness as genuine. The Medical Board also recommended that the leave period from 11.3.2021 to 3.9.2021 as leave on other than Medical Grounds (since the Medical Certificate issued is not genuine). The Medical Board has certified that the individual is fit to join duty on 4.9.2021 FN.

4. The Government have examined the report of the Medical Board in the reference 3rd read above carefully and order that Thiru. R. Baskar, Executive Engineer (Civil), on return from leave is posted as Executive Engineer (Civil), Water Resources Department, Vellar Basin Division, Virudhachalam in the existing vacancy.

5. The previous posting orders issued to Thiru. R. Baskar, Executive Engineer(Civil) in the Government Order first read above is hereby cancelled.

6. The Engineer-in-Chief, Water Resources Department, and Chief Engineer (General), Public Works Department, Chennai is directed to regularize the period of absence of Thiru. R. Baskar, Executive Engineer(Civil) from 1.2.2021 to 3.9.2021 as recommended by the Medical Board in the reference 3rd read above.
