How ever it has been brought to our notice that some of the reporting authorities have not yet written Confindential Report for their Sub-ordinate Engineers, while some of the Confidential Reports are pending with reviewing authority for want of their scrutiny in time. In view of this it is difficult for Chief Engineer (General) office to compile Confidential Report when ever promotion panels are under preparation.

Time and again we appealed to our member Engineers to write Confidential Report for their Sub-ordinate Engineers before 15<sup>th</sup> April of every year and send the same to Chief Engineer (General) office before 30<sup>th</sup> April of that year. The individual Assistant Engineers, Assistant Executive Engineers, Executive Engineers and Superintending Engineers should also nudge their Superior Officers to write the Confidential Report without delay. This will go long way in avoiding the delay in preparation of Promotion Panels.

Ref: G.O.Ms.No.256, PW (W2) Department, dated 01.10.2018

We invite your attention to the reference cited where in the Government had sanctioned creation of new Corporation named "Tamil Nadu Water Resources Conservation and River Restoration Corporation". The duties of the Corporation are mentioned in the para (6) as below: -

"the duties of this Corporation shall include, among other things, to prepare Detailed Project Reports, to prepare Request for Proposal, to call for Tender / Bids and to execute the projects and also advise Public Works Department in executing the projects as and when necessary"

From the above it is clearly understood that the duties of the Corporation overlap with the duties of the Water Resources Department and will exercise duplicate authority.

Moreover the staff of the above said Corporation will be recruited on consolidated pay among retired Bureaucrats / Engineers and hence will have no accountability to the duties entrusted to them.

The Water Resources Department Engineers are capable of doing the same work and the establishment of this Corporation is a wasteful expenditure for the Government.

We request the Additional Chief Secretary to Government to kindly look into the matter and request suitable action to close the above Corporation.

Sir,

The promotion of Assistant Engineers as Assistant Executive Engineers in Water Resources Department and Public Works Department (Buildings) is stalled due to various Court cases / orders and due to this around 500 posts of Assistant Executive Engineers are vacant in both the Departments. The Hon'ble Minister for Water Resources Department also placed this in the Assembly and wondered how to maintain quality of works where such large number of Assistant Executive Engineers posts are vacant in the Department.

Since the new Government under Hon'ble Chief Minister of Tamil Nadu Thiru.M.K.Stalin is taking every step to fill up all the vacant posts, the Court cases / orders become hurdle in Water Resources Department and Public Works Department.

From 2007 onwards Assistant Engineers are recruited separately for Buildings and WRD in PWD. The Court orders stalling the promotion were filed and obtained by 5 numbers of Assistant Engineers working in WRD and there was no case or order in the name of Assistant Engineers recruited under Buildings branch of PWD.

Since now the Departments of Buildings and WRD are functioning separately, the Assistant Executive Engineer vacancies in Buildings Department are to be filled up by the Assistant Engineers recruited separately for building in 2007 and subsequent batches. The Assistant Engineers of Buildings branch have not filed any separate case in the roster versus merit and not obtained any orders in this regard. Only the stay in temporary promotion of Assistant Executive Engineers & Executive Engineers in standing their way. Moreover all the Assistant Engineers of 2007 (Buildings) will got promotion and there will be no seniority issues between them. They have also given their consent letter for not involving in the case regarding their promotion.

The Promotion Panel for various categories such as Assistant Executive Engineer, Executive Engineer and Superintending Engineer have been delayed for a very long period, eventhough a lot of vacancies are available in all categories due to various court cases in fixation of seniority for the TNPSC Assistant Engineers.

Now, we came to understand that the Government of Tamil Nadu is going to take a final decision soon regarding the seniority among TNPSC selected Assistant Engineers in view of the recent Hon'ble Supreme Court of India orders.

In the meantime we come to understand that the Engineer-in-Chief, WRD & Chief Engineer (General), PWD and Engineer-in-Chief (Buildings) and Chief Engineer (Buildings) Chennai Region, PWD are considering to promote the Engineers coming under the 25% quota (1 Ratio) only, and Engineer-in-Chief, WRD & Chief Engineer (General), PWD has called for latest Confidential Reports of those who comes under the 25% quota (1 Ratio) only.

At this juncture, we would like to bring your kind attention that Hon'ble High Court of Madras has issued a Stay Order (WP No.35161 & 34153 of 2019) for any Temporary Promotion.

# **GOVERNMENT ORDERS**



Fundamental Rules – Instruction 4(b) under Fundamental Rule 44 – House Rent Allowance while on leave – Amendment – Orders – Issued.

Human Resources Management (FR-II) Department G.O. (Ms)No.89 Dated : 09.09.2021 Read:

- 1. G.O. (Ms.) No.105, Personnel and Administrative Reforms (FR-III) department, dated 07.11.2016.
- 2. G.O. (Ms.) No.154, Personnel and Administrative Reforms (FR-II) department, dated 05.12.2017.
- 3. From the Principal Secretary / Commissioner of Treasuries and Accounts, Chennai-35, Letter Rc.No.28571/D2/2019, dated 22.08.2019
- 4. G.O.(Ms.) No.84, Human Resources Management (FR-III) department, dated 23.08.2021

### ORDER:

Instruction 4(b) under Fundamental Rule 44 provides that "While on leave with allowance, - A Government servant, shall be permitted to draw house-rent allowance for six months of leave including maternity leave but not extraordinary leave. He shall be paid house-rent allowances during the period of leave at the rates at which he was entitled to it prior to going on leave irrespective of whether he is reposted to the same station or not."

2. In the Government Order first read above, orders were issued extending the maternity leave from 180 days to 270 days to married women

Government servants. In the Government Order second read above, Instruction 1 under Fundamental Rule 101(a) has been amended accordingly.

3. In the Government Order fourth read above, orders were issued enhancing the maternity leave from 9 months (270 days) to 12 months (365 days) to married women Government servants.

4. The Government have examined the above provisions under Fundamental Rules. The grant of maternity leave under rule 101(a) of Fundamental Rules is an exception and special concession under section VI in part IV of the Fundamental Rules and House Rent Allowance shall be permissible for the entire period of maternity leave. Therefore, the Government decided to amend Instruction 4(b) of Fundamental Rule 44 suitably and accordingly, the following notification will be published in the **Tamil Nadu Government Gazette:-**

In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to the Fundamental Rules and the Instructions thereunder.

2. The amendment hereby made shall be deemed to have come into force on the  $7^{th}$  November 2016.

#### AMENDMENT

In the said Fundamental Rules, in rule 44, under the heading "INSTRUCTIONS UNDER RULE 44", in instruction 4, in clause (b), the expression "including maternity leave" shall be omitted.

2. The amendment hereby made shall be deemed to have come into force on  $31^{st}$  December, 2014.

# **AMENDMENT**

In the said Fundamental Rules, for rule 26-A, the following rule shall be substituted, namely:-

"26-A. The Government servant, who retires on or after the 31<sup>st</sup> December '2014 and whose increment falls due on the next day following the date of superannuation, in accordance with the provisions under rule 26, shall be sanctioned with one increment at the eligible rate, notionally on the afternoon of the date of retirement, purely for pensionary benefits only:

Provided that the Government Servant, who retired prior to 31<sup>st</sup> December 2014, is also eligible for sanction of annual increment notionally on the afternoon of the date of retirement for the purpose of revision of pension with monetary benefit with effect from 31<sup>st</sup> December 2014. The rate of notional increment shall not exceed the eligible rate based on the basic pay drawn by the Government Servant as on the date of retirement.".

- Sub: Tamil Nadu Fundamental Rules Maternity Leave Enhancement of Maternity Leave from 9 months (270 days) to 12 months (365 days) – Clarification – Issued.
- Ref: G.O. (Ms.) No.84, Human Resources Management (FR.III) Department, dated 23.08.2021.

In the Government Order cited above, orders have been issued as follows: -

"The maternity leave admissible to married women Government servants with less than two surviving children, which is 9 months (270 days) at present, be enhanced to 12 months (365 days), with effect from 01.07.2021, with full pay, which may be spread over from the pre-confinement rest to post-confinement recuperation, at the option of the married women Government servants. The women Government servants who proceeded on maternity leave prior to 1<sup>st</sup> July 2021 and continue to be on that leave on or after that date shall also be eligible for maternity leave for a period not exceeding 365 days in total."

2. It has been brought to the notice of Government that some of the women Government Servants who were on maternity leave on 01.07.2021 or after that date have joined duty on completion of 270 days before the issue of G.O.(Ms)No.84, Human Resources Management (FR-III) Department, dated 23.08.2021 enhancing the admissible maternity leave from 270 days to 365 days with effect from 01.07.2021. Similarly, some of them have continued their leave, on completion of 270 days of maternity leave as earned Leave / Unearned Leave on Medical Certificate / Extra ordinary Leave Without pay and allowances etc.,.

3. As the enhancement of maternity leave takes effect from 01.07.2021 as per the Government Order cited above and the date of issue of Government order is 23.08.2021, it is clarified that the cases of married women Government Servants who were on maternity leave on 01.07.2021 or after that date, but joined duty on completion of 270 days before the issue of G.O.(Ms) No.84, Human Resources Management (FR-III) Department, dated 23.08.2021 may be considered for sanction of maternity leave, for the balance period out of 365 days in total, as per the above said Government Order from the date on which maternity leave was sanctioned to them initially, as and when representation is received from them within this period. The inbetween period from the date on which they joined duty and attended office may be treated as duty. Similarly, those who were on maternity leave on or after 01.07.2021 and subsequently continued their leave as earned Leave /

Unearned Leave on Medical Certificate / Extra ordinary Leave without pay and allowances etc., on completion of 270 days of maternity leave before the issue of above Government Order may also be considered for sanction of maternity leave as per G.O.(Ms) No.84, Human Resources Management (FR-III) Department, dated 23.08.2021 and in such cases the leave applied / sanctioned in continuation of maternity leave shall be modified as maternity leave. In all the above cases, the authority shall ensure that the maternity leave should not exceed 365 days in total, from the date on which maternity leave was sanctioned initially.
