### Commitment not honoured – Special Executive Engineer, Special Superintendenting Engineer not given to seniors.

While bifurcating our Public Works Department into Public Works Department and Water Resources Department in the G.O.Ms.No.158, Public Works (D2) Department, dated 01.11.2021 it was mentioned that whenever Juniors in one Department got promoted the Seniors in other Department will get their Promotion as Special Executive Engineer / Special Superintending Engineers immediately. However even after issue of Promotion to Juniors in Public Works Department, the Senior Assistant Executive Engineers in Water Resources Department are not getting their Special Executive Engineer post even after a lapse of more than 4 months. The file for the Special Executive Engineer Promotion is unnecessarily routed through Human Resources & Finance Department and they are returning the proposal with filmsy queries and dragging on this issue.

We appeal to the Government to issue Special Executive Engineer / Special Superintending Engineer promotion whenever orders are issued for promotion of Juniors are issued without routing through Human Resources & Finance Department (or) else.

We request to prepare common panel for both the departments and post them according to seniority in either departments until vacancy arises in their opted departments. This will solve this issue without causing bitterness among our member Engineers. - Editor

The PEC ratified the above, and appreciated, the TNEF for conducting the above meeting.

**Er.M.Suganthi**, Secretary, ENGIBEF explained that one **Er.V.P.Rajendran**, Assistant Engineer of Thanjavur Branch was expired on 20.05.2018. He Paid Rs.3000/- as part payment towards ENGIBEF. His family requested relief from ENGIBEF to his legal heir **Tmt.P.Nagamani** (Mother of **Er.V.P.Rajendran**). The same was recommended by the Thanjavur Branch. The PEC discussed this issue and decided to give an amount of **Rs.50,000/-** to the legal heir of the deceased **Er.V.P.Rajendran's** family.

After discussion by all the members, the following resolutions were unanimously passed.

In the Government Order fourth read above, orders have been issued on the guidelines for the vertical separation of the Department into

Public Works Department and Water Resources Department. Among others, it has been ordered that all further promotions / appointments from the year 2021-2022 has to be made by the respective Engineer-in-Chiefs of Public Works Department and Water Resources Department by formulating separate seniority lists as per the extant statutory rules.

- 2. In the fifth read above, orders have been issued fixing the estimate of vacancy for the post of Assistant Executive Engineers in Public Works Department for the year 2021-2022 as "244" (Two Hundred and Forty Four)
- 3. The following Writ Petitions are pending before the High Court of Madras with regard to fixation of seniority among Assistant Engineers appointed by direct recruitment and recruitment by transfer:

4. In the orders of the Hon'ble Division Bench of Madras High Court sixth read above, the Hon'ble Court has passed the following orders:

"we do not find any unconstitutionality in the Section of law under the challenge, i.e. Section 47(1). Rather, it has been framed to save the sufferings of the administration in the absence of the hands by way of regular promotion.

Taking into consideration the object of Section 47(1) and findings no illegality in the provision, we find no grounds to accept the prayer made in the Writ Petition. Accordingly, the Writ Petition is dismissed."

5. The Advocate General of Tamil Nadu in his legal opinion ninth read above has opined that;

"The temporary promotion under Section 47(1) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016, shall be invoked to save sufferings of the administration on temporary arrangements till the regular promotions to the posts are made. As observed by the Hon'ble First Bench of the High Court of Madras in its Judgement dated 17.03.2022 in W.P. No. 35161 of 2019, 'the administration may suffer on account of the delay in promotion and thus, the arrangements has been provided to fill the posts temporarily from a person possessing qualification prescribed for the posts.' Therefore, considering the change of circumstances and the large number of vacancies in the post of Assistant Executive Engineer, I am of the view that the authorities concerned can consider giving temporary promotion invoking Section 47(1) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016, subject to the outcome of W.P. No. 3617 of 2017 and batch cases, pending on the file of the Hon'ble High Court of Madras.

- 6. The Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chennai in his letters tenth read above, has furnished the name list of the 101 numbers of directly recruited Assistant Engineers through Tamil Nadu Public Service Commission and 66 numbers of Assistant Engineers appointed by the method of recruitment by transfer / Junior Engineers / Re-designated Assistant Engineers who are fully eligible to be temporarily promoted to the post of Assistant Executive Engineer in Civil branch of Public Works Department by invoking Section 47(1) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016. He has also certified that no disciplinary proceedings / criminal cases are pending against the individuals considered for temporary promotion.
- 7. In the letter tenth read above, the Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chennai has reported that as per the provisions of the G.O.(Ms.)No.1, Public Works Department, dated 02.01.1990, Technical Assistants, who have put up 5 years of service have been appointed to the post of Assistant Engineers. Amongst 21 Numbers of Technical Assistants appointed to the post of Assistant Engineers, 7 Numbers of serving Assistant Engineers have opted to serve in Public Works Department. However, the appointment of such 21 Numbers of Assistant Engineers by the method of recruitment by transfer from the post of Technical Assistants is itself in question, as the Hon'ble High Court of Madras in its Orders dated 23.12.2014 in WP No.11148 and 21344 of 2007, had allowed the Writ Petitions and had restrained the official respondents from making further appointment to the post of Assistant Engineer from the category of Technical Assistants by way of recruitment by transfer unless and until the Statutory Rule is amended making the post of Technical Assistants also as a feeder category, Assistant Engineers appointed from the post of Technical Assistants shall be permitted to continue as Assistant Engineers for a period of 3 months from the date of receipt of a copy of the orders of the

In case, the Rule is amended making the post of Technical Assistant as a feeder category for appointment to the post of Assistant Engineer, then they shall not suffer any reversion and they will be allowed to continue as Assistant Engineers. In case, the Rule is not amended within 3 months or in the case of earlier rejection of the proposal for inclusion of the post of Technical Assistant in the feeder categories, the private respondents shall be reverted back to their original post, namely Technical Assistants.

- 8. However, the 21 Numbers of Assistant Engineers had continued without reversion in view of the Status-Quo obtained by them in M.P. No.1 of 2015 in Writ Appeal No.82 of 2015 and in M.P.No.1 of 2015 in Writ Appeal No.95 of 2015 on 5.3.2015. Therefore, the Assistant Engineers appointed from the post of Technical Assistants can be considered for temporary promotion to the post of Assistant Executive Engineers only after the outcome of the Writ Appeals mentioned above filed before the Hon'ble High Court of Madras. The Advocate General of Tamil Nadu, Chennai has also taken note of the same in his legal opinion ninth read above and opined that Assistant Engineers promoted from the post of Technical Assistants cannot be considered for promotion and the Assistant Executive Engineer vacancies may be reserved.
- 9. The Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chennai has, therefore, requested orders of the Government for temporary promotion of 167 numbers of Assistant Engineers / Junior Engineers to the post of Assistant Executive Engineers in Civil Branch of Public Works Department as per the name list out of the total estimate of vacancy of 244 numbers for the post of Assistant Executive Engineer for the year 2021-2022, who are fully eligible to be temporarily promoted to the post of Assistant Executive Engineer, by invoking Section 47(1) of the Tamil Nadu Government Servant (Conditions of Service) Act, 2016, to mitigate the sufferings of the administration on temporary arrangements till the regular promotions to the posts are made.
- 10. The Government after careful examination of the proposal of the Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chennai, in the light of the legal opinion of the Learned Advocate General of Tamil Nadu have decided to accept it. Accordingly, the Government hereby order the temporary promotion / appointment of the following Assistant Engineers (Civil) / Junior Engineer (Civil) to the post of Assistant Executive Engineers (Civil), by invoking Sections 47(1) and 17(1) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016

respectively, subject to the outcome of W.P.No.3617 of 2017 and batch cases, pending on the file of the Hon'ble High Court of Madras:-

### Floating Solar Power Plant – A Global Cutting Edge alternative for non-renewable energy.

The millennium as we live in is being susceptible to more vulnerable weather occurrences starting from the rise in global temperature compared to pre-industrial levels, extreme floods, incessant rains, rise in the sea water level, sea water intrusion into the land, excessive drought etc., are all coupled due to the anthropogenic activities carried out to fetch the thirst of mankind. Considering the adverse climatic changes, the United Nations proposed the Sustainable Development Goals (SDG) to be attained by 2030 and it is expected from every individual and nation breathing on the Earth. This universal, integrated and transformative agenda aims to spur actions that will end poverty and build a more sustainable world over the next 15 years. India, being a developing nation has pledged itself in attaining all the 17 SDGs by 2030 and the same has been reiterated by our Honourable Prime Minister at the United Nations Framework Convention on Climate Change Conference of Parties (COP-26) held at Glasgow, Sweden.

Out of the 17 SDGs, providing Affordable and Clean Energy, 7th SDG becomes a prime goal for every developed and developing country in order to reduce the depletion of the planet. The roadmap for attaining this goal has been marked by our Honourable Prime Minister by setting certain aims such as to raise the non-fossil fuel based energy capacity to 500 GW by 2030, to meet 50% of the country's energy requirements using renewable energy sources by 2030 and to become carbon neutral and achieve net-zero emissions by 2070.

India primarily being a developing country and a global market, the energy to meet its demand is being met majorly from fossil fuels and only a small proportion is being attributed by the renewable energy sources such as wind, solar, hydro etc., It is now high time to move towards the renewable energy sources and do more investment and research to explore the marvels hidden in kindling the renewable energy sources. Research and Development in most of the developed countries have strained themselves to find the panacea to the more exacerbating lacuna of compensating their energy demand through renewable energy sources. One such solution found in the Norwegian countries is the installation of wind turbines fixed to the ocean floor in shallow seas and the floating wind turbines moored to the ocean bed in deep waters.

Moving on to our Nation, installation of solar panels over the barren lands which are sun-rich have always been a way to capture the energy until last decade considering the research carried out in the photo-voltaic cells and their installation. However the most recent global cutting edge technology helps in the innovation of floating solar panel over the water bodies and connecting the energy observed to the nearby grid for electricity transmission. Last year, India's biggest floating solar power plant of generation capacity, 100 MW has been developed by the National Thermal Power Corporation Limited (NTPC) at Ramagundam in Peddapalli district of Telangana.

Installation of floating solar panel over the inland water bodies has its own merits and challenges. Each and every challenge has to be explored in detail pertaining to a site and has to be considered.

The key challenges that face renewable energy plant owners are land acquisition, grid connectivity, regulations and off-take. Floating solar plants balance high population density and competing uses for available land. The land can be used for other purposes, such as farming, construction or life basic activities. The bodies of water exert a cooling effect, which improves the performance of solar photovoltaic panels by 5-10%. Over time, this transforms into significant cost savings. Other Advantages are reduced grid interconnection costs, reduced water evaporation, improved water quality and reduced algal blooming.

The key challenges involved in the installation of floating solar panel are the Engineering and construction costs which are usually higher than those of a ground-mounted solar farm. Since floating solar involves water and electricity, more consideration must be given to cable management and insulation testing than on land, especially when cables are in contact with water. A floating solar plant has moving parts that are subject to constant friction and mechanical stress. Systems that are poorly designed and maintained could suffer from catastrophic failures. The installation is at risk of degradation and corrosion due to moisture, especially in more aggressive coastal environments. Developing floating solar projects requires a thorough understanding of water-bed topography and its suitability for setting up anchors for floats.

The possibility of exploring the opportunities of the installation of floating solar panel in the inland water bodies ie., reservoirs of Tamil Nadu cannot be left unquestioned. As Tamil Nadu Water Resources Department owns nearly 90 reservoirs in the state, installation of floating solar panels can be done without any inter-departmental complexities. As most of the dams in the state are located either near the foot hills or in the plains, installation of the floating solar panels might be an easy task compared to the dams which are located in the mountain ranges which are subjected to frequent rains and flash floods. The grid connection to transfer the power generated has to be within the vicinity of the dam in order to avoid transfer losses and this can be ascertained in Tamil Nadu as considerable amount of TNWRD dams have the power generation capability in co-ordination with the Tamil Nadu Electricity Board. Also the state lies very much closer to the Tropic of Cancer, abundance of sun light would never be a indefinite task.

Installation of floating solar power plant in the dams located along the plains has its own advantages. Due to the effect of the direct sunlight, evaporation losses can be minimised by protecting the water body by the installation of floating solar panels. Thereby this leads to the increase in the ground water levels in the adjoining areas of the dam/ reservoir. Aquaculture would also flourish thereby leading more revenue to the people dependant on the living organisms of the reservoir. More employment would be created leading to increase in the economy of the state. More start ups would also be rising as an initiation of Make in India program also attracting more Foreign Direct Investment. More clean energy from the nature whereby the Sustainable Development Goal would be attained by reducing the carbon footprint from the atmosphere.

#### Few words from the drafter of the article:

The idea proposed above is just a mere replica from the articles found in the newspapers. But the main objective of this article is to instil the minds of the fellow Engineers regarding the possibilities of adding more revenue to the State and become self-reliant energy sufficient state among all states in the nation.

Finally it is requested that these kind of new techniques have to be enunciated to the future Engineers and provide a stimulus for them to exhibit the trust of the common public on this department.

In the letters second and third read above, the Engineer-in-Chief (Buildings), Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai has stated that the Electrical Wing of Public Works Department is functioning with 3 numbers of the Joint Chief Engineer (Electrical), 8 numbers of Electrical Division with supporting Sub-Divisions and sections. The Middle Level engineer in the Electrical Wing is presently named as "Electrical Engineer"; This nomenclature creates perplexity and confusion in recognition of middle level Engineer; as it relates more to the field of Electrical Engineer rather than the level / grade of Engineers in electrical field. The Electrical Division headed by Electrical Engineer was formed during 1962 and prior to 1980, the Government Buildings were only less in number and the Electrical provisions in Government Buildings were restricted to only Lights and Fans after which the construction of Government Buildings has drastically increased. Later, buildings are being provided with H.T. Service connections, Air-conditioning facilities Lifts, Generators, etc. Hence, the work load for Electrical Engineer is increased and also the jurisdiction of each Electrical Division is enhanced simultaneously.

- 2. In order to handle the increasing work load, the Electrical Wing of Public Works Department has been developed into 8 Electrical Divisions located at Madurai, Chennai, Trichy, Sivagangai (shifted to Tirunvelveli) and Coimbatore. Later, in Government Order first read above, orders have been issued for reorganization of Electrical Divisions in Public Works Department.
- 3. The functions, duties and responsibilities of Electrical Engineer are equivalent to the Executive Engineers of Civil Wing of Public Works Department. Therefore, to prevent misinterpretation, the Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chennai in his letter third read above, has requested to change the nomenclature of "Electrical Engineer" in Section 10, Part II of Branch V Electrical of the Tamil Nadu Engineering Service as "Executive Engineer (Electrical)", in line with the Civil Wing of Public Works Department and on par with the other Engineering Departments of Government of Tamil Nadu.
- 4. The Government after careful examination of the proposal of the Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chennai have decided to accept it. Accordingly, the Government directs that the nomenclature of "Electrical Engineer" in Section 10, Part II of Branch V Electrical of the Tamil Nadu Engineering Service be changed as "Executive Engineer (Electrical)", subject to the conditions that, no change in pay and promotional conditions should arise due to re-designation, promotion avenue of feeder category should not be disturbed no further claim of any nature including pay, promotion, cadre strength, internal transfers and postings, feeder category or any other entitlement on principles of parity or even otherwise etc., should not arise out of such re-designation and the terms and service conditions should remain the same.
- 5. The Engineer-in-Chief, Chief Engineer (General) and Chief Engineer, Chennai Region, Public Works Department, Chennai is also directed to send suitable amendment proposal in this regard for amending the Tamil Nadu Engineering Service.

**PENSION/FAMILY PENSION** – Simplification of mustering process – Inclusion of various options at the convenience of the Tamil Nadu State Government Pensioners for mustering and producing Life Certificate / Digital Life Certificate by utilizing the Door Step Services of the India Post Payments Bank (IPPB) from the year 2022 onwards – Orders – Issued.

#### ORDER:

In the Government Order first read above, orders were issued allowing the pensioners to submit their Life Certificate at any time during the months of July, August and September every year for annual mustering instead of April, May and June to the concerned Pension Disbursing Officers.

- 2. In the Government Orders second and third read above, considering the Covid-19 pandemic, the Government have temporarily exempted the Annual Mustering process for the years 2020 and 2021 as a special case by relaxing S.R.67(a)(1) and S.R.71(a)(1) of Treasury Rule 16 of Tamil Nadu Treasury Code Volume-I.
- 3. At present, mustering can be done by Pensioners / Family Pensioners by exercising any one of the following options;
  - i. Direct Mustering (Physical Appearance).
  - ii. Submission of Life Certificate through Post.
  - iii. Digital Life Certificate (DLC) through Jeevan Pramaan Portal by using biometric device.
- 4. The Commissioner of Treasuries and Accounts has furnished a proposal to include the services of the India Payments Bank (IPPB) as one of the facilitator to do mustering of the State Government Pensioners through Jeevan Pramaan Portal in addition to the existing methods of Mustering. He has also stated that the Assistant General Manager, India Post Payments Bank (IPPB), Tamil Nadu Circle has stated that, they are having 11018 Banking Access Points and 14723 Banking Service Providers within Tamil Nadu State with adequate infrastructure for generating Digital Life

Certificate (DLC) through Jeevan Pramaan Portal and proposed to charge Rs.70/- per DLC for rendering the services.

- 5. In the revised proposal, the Commissioner of Treasuries and Accounts has sent proposal requesting to permit him to share the following details of the Pensioners with India Post Payments Bank (IPPB's) in order to facilitate plan and allocate India Post Payments Bank's resources to provide Door Step Digital Life Certificate (DLC) generation services to the pensioners by giving wide publicity.
  - a) Pensioners Name.
  - b) Aadhar Number or Virtual ID (Registration of Aadhar with the Pension Disbursing Authority should have been done already).
  - c) Address with pin code.
  - d) Mobile Number.
- 6. After careful examination of the proposal of the Commissioner of Treasuries and Accounts, the Government accord permission to share the above details of Pensiones/Family Pensioners and carry out mustering process on a regular basis from the current year 2022 in the months of July, August and September. The Pensioners shall at their convenience be allowed to choose any one of the following facilities; -
  - 1) Digital Life Certificate (DLC) through Jeevan Pramaan Portal by using the services of any one of the following entities as per the option of the pensioners.
  - a) India Post Payments Bank (IPPB) with Door Step Service.
  - b) e-Seva centres / Common Service Centers.
  - c) Pensioners' Associations having biometric device connected with Jeevan Pramaan Portal.
  - 2) Submission of Life Certificate through Post.
  - 3) Direct Mustering (Physical Appearance).
- 7. The Commissioner of Treasuries and Accounts is directed to appoint a Nodal Officer in each District Treasury and also give wide publicity on Door Step Services on Digital Life Certificate by the india Post Payments Bank (IPPB) through Social Media, Advertisement in newspapers and insist the IPPBs to also advertise and reach the Pensioners / Family Pensioners through the Post Offices throughout the State. All the Treasury Officers / Sub-Treasury Officers / Pension Pay Officers shall motivate e-mustering by giving wide publicity and facilitate the Pensioners / Family Pensioners and ensure that at least 80% Annual mustering is done through Jeevan Pramaan portal utilizing the Door Step Services of IPPB / e-Seva Centre / CSC / Pensioners' Association having Bio-Metric Devices thereby avoiding hardship to the aged Pensioners / Family Pensioners of coming to the Pension Office / Treasuries in person for Mustering. The District Treasury Officers shall be personally liable to ensure that all necessary arrangements are made to achieve this objective.

#### FINANCE (Health Insurance) DEPARTMENT G.O.Ms.No.142, Dated 24<sup>th</sup> May, 2022 ABSTRACT

**MEDICAL AID** – New Health Insurance Scheme for Pensioners (including spouse) / Family Pensioners – Continuance of the New Health Insurance Scheme beyond 30.06.2022 – Orders – Issued.

#### Read the following:-

- 1. G.O.Ms.No.462, Finance (Pension) Department, Dated 27.12.2013.
- 2. G.O.Ms.No.171, Finance (Pension) Department, Dated 26.06.2014.
- 3. G.O.Ms.No.222, Finance (Pension) Department, Dated 30.06.2018

#### ORDER:

In the Government Order third read above, orders were issued implementing the "New Health Insurance Scheme, 2018 for Pensioners (including spouse) / Family Pensioners" on CASHLESS basis with assistance upto Rupees four Lakh and for some specified illness treatment upto a maximum assistance of Rs.7.50 lakhs for a block period of four years from 01.07.2018 to 30.06.2022 through the United India Insurance Company Limited with a contribution of Rs.350/- by the Pensioners / Family Pensioners.

- 2. The Government has examined the need for continuation of Health Insurance Scheme for Pensioners (including spouse) / Family Pensioners and decided to continue the same. Accordingly, the Government direct that the New Health Insurance Scheme, 2022 for Pensioners (including spouse) / Family Pensioners shall be implemented from 01.07.2022 with the following salient feathers:
  - i. New Health Insurance Scheme, 2022 for Pensioners (including spouse) / Family Pensioners shall be implemented from 01.07.2022 for a further block period of four years from 01.07.2022 to 30.06.2026.
  - ii. A suitable Public Sector Health Insurance Company shall be selected through National Competitive Bidding as was done in New Health Insurance Scheme, 2018 for Pensioners (including spouse) / Family Pensioners as per policy decision of the Government.
  - iii. The ceiling on medical assistance shall be enhanced from Rs.4.00 lakh to 5.00 lakh for a block period of 4 years for Pensioners (including spouse) /

- Family Pensioners. However the ceiling on medical assistance shall be enhanced upto Rs.10.00 lakh for specified illness like cancer, liver and other transplantations etc., as is extended to the serving employees.
- iv. COVID 19 cases shall also be covered under specified illness category and maximum assistance upto Rs.10.00 Lakh shall be extended as applicable under the New Health Insurance Scheme, 2021 for Government Employees.
- v. Dependents of Pensioners who are eligible for Family Pension as per the Tamil nadu Pension Rules, 1978 shall also be covered under the scheme.
- vi. The monthly subscription to be recovered from the Pensioners / Family Pensioners will be firmed up based on the Insurance Premum payable to the Insurance Company.
- vii. The medical treatment taken by the Pensioners / Family Pensioners in Non-Network hospital under Non-Emergency situation shall also be covered on reimbursement basis.
- viii. The hospitals already accredited under New Health Insurance Scheme, 2021 for CASHLESS treatment shall be made applicable to this scheme also. The Government Hospitals which were empanelled under Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) shall also be empanelled as Network Hospitals under this Scheme. Additional hospitals and treatment / surgeries for CASHLESS treatment will be added on the recommendation of the Accreditation Committee as and when necessity arises.
- ix. The Treatments and Surgeries under Broad Based Specialities already approved for the New Health Insurance Scheme, 2021 for Employees shall be made applicable to this scheme also.
- x. This scheme shall also be extended to the Pensioners / Family Pensioners of the Local Bodies, Statutory Boards, State Public Sector Undertaking, Universities, where these organizations elect to adopt the scheme subject to payment of premium at the rate as fixed by the Government directly to the Insurance Company. The excess of premium over and above the Pensioners / Family Pensioner's contribution shall be borne by the respective organization.
- 3. The orders on further modalities, terms and conditions for the implementation of the New Health Insurance Scheme, 2022 for Pensioners (including spouse) / Family Pensioners shall be issued separately.
