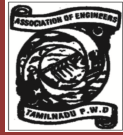

**7<sup>th</sup> Pay Commission Pay Scale to our Engineers – Urgent action requested:**

The Pay Scale and status given by former Chief Minister of Tamil Nadu **Dr.Kalaignar** to our Engineers (Assistant Engineers, Assistant Executive Engineers and Executive Engineers) in the year 2011 and reduced by Official Committee & Judicial Committee which reflected the prejudiced view of some people who are dead against giving due Pay Scale & Status to our AEs, AEEs & EEs. The result is we are still continuing in the 6<sup>th</sup> Pay Commission Pay Scales by the benevolence of Court order only.

Eventhough 7<sup>th</sup> Pay Commission Pay Scales are extended to all Government servants from October 2017 onwards our Engineers (AEs, AEEs & EEs) are not able to get their new Pay Scale equivalent to the 6<sup>th</sup> Pay Commission Pay Scale. Due to this our AEs, AEEs & EEs have lost many of the benefits like new T.A and Allowances, increased DCRG for retired Engineers etc.

Now in some of PAOs routine increment, selection grade & promotion Pay Scale are also denied by way of Audit objection, thus indirectly forcing us to move to reduced 7<sup>th</sup> Pay Commission Pay Scales. We are forced to take further legal action in the High Court to stop this illegal move by some of PAOs.

We once again appeal to our Hon'ble Chief Minister to intervene in this matter and restore the Pay Scale & Status for our AEs, AEEs & EEs as ordered by former Chief Minister of Tamil Nadu **Dr.Kalaignar**.

- நீர்வளத்துறையில் 204 உதவிப்பொறியாளர் (சிவில்) பணியிடத்திற்கான காலியிட மதிப்பீட்டினை இந்த ஆண்டு அறிவிக்கையிலே வெளியிட்டு தேர்வு செய்திட தமிழ்நாடு அரசுப் பணியாளர் தேர்வாணையத்திற்கு அனுப்பிய முதன்மைத் தலைமைப் பொறியாளர் மற்றும் தலைமைப் பொறியாளர் (பொது), நீர்வளத்துறை அவர்களுக்கு எங்கள் மனமார்ந்த நன்றியினைத் தெரிவித்துக்கொள்கிறோம்.
- நீர்வளத்துறையில் (2022-23-ஆம் ஆண்டிற்கு) ஒப்புதலளிக்கப்பட்ட 29 செயற்பொறியாளர்களின் பதவி உயர்வு பட்டியலில் வரிசை எண்.15 (பொறி.P.கோமதிநாயகம் வரை) பதவி உயர்வு வழங்கப்பட்டுவிட்டது. பதவி உயர்வு பெற்றுள்ள அனைத்து பொறியாளர்களுக்கும் எங்களின் மனமார்ந்த வாழ்த்துக்களைத் தெரிவித்துக்கொள்கிறோம். பதவி உயர்வு வழங்கிட ஆணை பிறப்பித்த மாண்புமிகு நீர்வளத்துறை அமைச்சர் அவர்களுக்கும், விரைவு நடவடிக்கை மேற்கொண்ட அரசு கூடுதல் தலைமைச் செயலாளர், நீர்வளத்துறை அவர்களுக்கும், முதன்மைத் தலைமைப் பொறியாளர் மற்றும் தலைமைப் பொறியாளர் (பொது), நீர்வளத்துறை அவர்களுக்கும், இணைத் தலைமைப் பொறியாளர் (பொது), நீர்வளத்துறை அவர்களுக்கும் மற்றும் தலைமைப் பொறியாளர் அலுவலகம் மற்றும் தலைமைச் செயலக அலுவலர்களுக்கும் எங்களின் நன்றியினைத் தெரிவித்துக்கொள்கிறோம்.
- நீர்வளத்துறை மற்றும் பொதுப்பணித்துறையில் தற்போது காலியாக உள்ள உதவிச் செயற்பொறியாளர் (சிவில்) பணியிடங்களை தற்காலிக பதவி உயர்வின் மூலம் நிரப்பிட முதன்மைத் தலைமைப் பொறியாளர் மற்றும் தலைமைப் பொறியாளர் (பொது), நீர்வளத்துறை மற்றும் முதன்மைத் தலைமைப் பொறியாளர் மற்றும் தலைமைப் பொறியாளர் (பொது), பொதுப்பணித்துறை அவர்களிடமும் கோரிக்கை விடுத்துள்ளோம். இந்தப் பதவி உயர்வு தொடர்பாக உச்சநீதிமன்றத்தில் உள்ள வழக்குகளின் நிலையைப் பொறுத்து இப்பதவி உயர்வு வழங்கப்படும் என தெரிவித்துக்கொள்கிறோம்.

✍ புதிய ஊதிய விகிதம் தொடர்பான வழக்கில் தடையாணை இருந்தும் நமது பொறியாளர்களுக்கு ஆண்டு ஊதிய உயர்வு / தேர்வுநிலை / பதவி உயர்வுக்கான ஊதியக்கட்டு ஆகியவற்றை வழங்காமல் சம்பளக் கணக்கு அலுவலகங்களில் புதிய தடையை ஏற்படுத்துகின்றனர். இவற்றை பெறுவதற்கு நமது பொறியாளர்கள் (சங்கம் வழியாக) நிதித்துறையின் மீது உயர்நீதிமன்றத்தில் புதிய வழக்குகளை தொடுத்துள்ளனர். மேலும், நீதிமன்ற அவமதிப்பு வழக்கும் தொடர்படவுள்ளது. இந்தப் பிரச்சனையில் அரசு நம்மை அழைத்துப் பேசி தீர்வு காண வேண்டும் என மாண்புமிகு அமைச்சர்கள் மூலமாக தொடர்ந்து வலியுறுத்தி வருகிறோம். விரைவில் நல்ல தீர்வை எதிர்பார்ப்போம்.

## **Minutes of the PEC Meeting of AOE & AEA held on 27.10.2022 at Office Premises**

The 6<sup>th</sup> combined PEC meeting of AOE & AEA, TNPWD was held on 27.10.2022 in the Association Office, Chepauk, Chennai-5 by about 6.15 P.M.

Since Er.R.Sornakumar, President, AOE was pre-occupied with urgent office works Er.K.Prabakar Vice-President, AOE presided the meeting.

Er.K.Prabakar, welcomed all the PEC members and requested them to actively participate in the Association activities. He explained to the member about the recent developments in the PWD & WRD and requested the GS, AOE to brief the subject agenda.

Er.K.Murugan, General Secretary, AOE explained in detail to the members about the following subject agenda.

- 1) Recruitment of Assistant Engineers in WRD & PWD – Present Stage.**
- 2) Promotion Panels & Postings – Present Stage.**
- 3) Pay Scale – Present Stage.**
- 4) Court Cases – Present Stage.**
- 5) Improvements to PRI.**
- 6) ENGIBEF V Phase – Present Stage.**
- 7) Any other Subjects.**

Er.M.Mathan, General Secretary, AEA explained to the members about the recent developments in Pay Scale issue like not giving increment / selection grade and promotion Pay Scale to our Assistant Engineers by the PAO, Chennai.

Er.V.Ponraj, Treasurer, ENGIBEF presented the present stage of ENGIBEF V Phase and requested to achieve a target of minimum of 1000 members in ENGIBEF V Phase so as to increase the benefit to deceased members family to Rs.4.00 lakh or 5.00 lakh.

Er.K.Murugan, General Secretary, AOE presented in the PEC about the proposed leak proof work for our Association Office and changing the damaged name board and fixing a new one. Both the works cost approximately 1.20 lakh and the PEC approved the same.

The request of the employees of PRI for 10% increase in their salary with effect from July 2022 was discussed in the meeting. The PEC decided to approve a 5% salary increase for PRI employees w.e.f. July 2022 as given to our Association office staff.

After detailed discussion the following resolutions were unanimously passed.

1. Resolved to thank the Engineer-in-Chief and Chief Engineer (General), PWD & Engineer-in-Chief and Chief Engineer (General), WRD for causing recruitment of Assistant Engineers in PWD & WRD.
2. Resolved to thank the Hon'ble Minister for WRD & Ho'ble Minister for PWD for approving the promotion panel of Chief Engineers, Superintending Engineer and Executive Engineers in WRD & PWD in record time.

The PEC also thanked the Additional Chief Secretary, WRD & Principal Secretary, PWD, Engineer-in-Chief and Chief Engineer (General), PWD & Engineer-in-Chief and Chief Engineer (General), WRD, Joint Chief Engineer (General), WRD and Joint Chief Engineer (Buildings), PWD and the Staff of Secretariat and Engineer-in-Chief offices for their support for issuing promotion panel & posting to Chief Engineers, Superintending Engineers and Executive Engineers in WRD & PWD.

3. Resolved to request the Government, PWD to approve the promotion of 2009 TNPSC selected Assistant Engineers as Assistant Executive Engineers under temporary promotion and fill up the existing Assistant Executive Engineer vacancies in PWD.
4. Resolved to request the branches to collect Legal Fund from all members so as to pursue the Pay Scale cases and other service matter related cases in High Court of Madras & Supreme Court of India. Also resolved to file court case for obtaining routine increment for Assistant Engineers who were denied their increment by PAO Chennai.
5. Resolved to carry out all improvement works in PRI for the benefit of our member engineers.
6. Resolved to achieve a minimum target of 1000 members in ENGIBEF Phase V early so as to enhance the benefit to the deceased members family.
7. Resolved to approve the leak proof work and change of damaged name board in our Association office at an approximate cost of Rs.1.2 lakh.
8. Resolved to approve the salary increase of 5% for the PRI staff w.e.f. July 2022 as given to our Association office staffs.

The meeting came to end with vote of thanks by Er.A.Abdul Khudus, President, AEA by about 8.00 P.M.

### **ABSTRACT**

Fundamental Rules and Tamil Nadu Leave Rules, 1933 – Encashment of leave benefits to the Government servants who were not allowed to retire from service but retained in service under rule 56(1)(c) of Fundamental Rules and who were dismissed / removed / resigned from service – Amendamental Rules and Tamil Nadu Leave Rules, 1933 – Orders – Issued.

### **ORDER:**

Rule 86(a)(i) of Fundamental Rules and rule 7(i) of Tamil Nadu Leave Rules, 1933 provide that the encashment benefits of earned leave and leave on private affairs at the credit of a Government Servant can be drawn and disbursed by the competent authority on the date of retirement or on the termination of extension of service as the case may be. Further, rule 21 of Tamil Nadu Pension Rules, 1978 clearly states that dismissal or removal of Government servant from a service or post entails forfeiture of his past service. Similarly, rule 23 of Tamil Nadu Pension Rules, 1978 clearly states that resignation from a service or post entails forfeiture of his past service.

2. The Government have reviewed the above provisions under the Fundamental Rules and the Tamil Nadu Leave Rules, 1933 in the light of the above provisions under the Tamil Nadu Pension Rules, 1978 and decided to make suitable amendments to the Fundamental Rules and the Tamil Nadu Leave Rules, 1933.

3. Accordingly, the following notification shall be published in the Tamil Nadu Government Gazette:-

### **NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and all of other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendments to the Fundamental Rules:-

### **AMENDMENTS**

In the said Fundamental Rules:-

(1) after rule 52, the following rules shall be inserted, namely:-

"52-A. **Forfeiture of service on dismissal or removal.** – Dismissal or removal of a Government servant from service entails forfeiture of his past service.

52-B. **Forfeiture of service on resignation.** – Resignation from a service or post entails forfeiture of past service:

Provided that a resignation shall not entail forfeiture of past service if it has been submitted to take up, with proper permission, another appointment, whether temporary or permanent, under the Government where service qualifies":

(2) In rule 65, in ruling (5), for the expression "**Article 418 (b) of the Madras Pension Code**", the expression "**the proviso to sub-rule (1) of rule 23 of the Tamil Nadu Pension Rules, 1978**" shall be substituted.

(3) in rule 86.-

(a) the expressions "or on the date of termination of extension of service, as the case may be" and "or the date of termination of extension of service" wherever they occur, shall be omitted:

(b) in sub-rule (a),-

(i) after clause (iii), the following provisions shall be inserted, namely:-

"Provided that the Government servants who are dismissed or removed from service or who have resigned from service shall not be eligible for encashment of earned leave and leave on private affairs.

Provided further that the encashment of earned leave and leave on private affairs shall be deferred to the Government servants who are not permitted to retire from service on attaining the age of superannuation but retained in service under Fundamental Rule 56(1)(c), till the enquiry into the charge of misconduct or criminal misconduct is/are concluded and final order passed thereon by the competent authority. The said benefit of encashment of earned and leave on private affairs shall be drawn and disbursed to such Government servants after regulating their suspension period.";

(ii) under the Explanation, clause (i) shall be omitted:

(4) in Appendix – I, in Annexure – III, in the Tamil Nadu Leave Rules, 1933,-

(a) in rule 7,-

(i) the expression "or on the date of termination of extension of service, as the case may be" and "or on the date of termination of extension of service" wherever they occur shall be omitted;

(ii) after clause (iii), the following provisions shall be inserted, namely:-

"Provided that the Government servants who are dismissed or removed from service or who have resigned from service shall not be eligible for encashment of earned leave and leave on private affairs:

Provided further that the encashment of earned leave and leave on private affairs shall be deferred to the Government servants who are not permitted to retire from service on attaining the age of superannuation but retained in service under Fundamental Rule 66(1) (c), till the enquiry into the charge of misconduct or criminal misconduct is/are concluded and final order passed thereon by the competent authority. The said benefit of encashment of earned leave and leave on private affairs shall be drawn and disbursed to such Government servants after regulating their suspension period”.

(iii) under the Explanation, clause (i) shall be omitted;

(b) in rule 8, in sub-rule(b),-

(i) in the third proviso, the expressions “or resign” and “or resignation, as the case may be” shall be omitted;

(ii) in the fourth proviso, the expression “is removed or dismissed from service or” occurring in two places and the expression “as the case may be” shall be omitted.

**ABSTRACT**

Land Acquisition – Revised Administrative sanction for the Land Acquisition Cost – Simplified Procedures – Reduction of Financial burden – Orders Issued.

**ORDER:**

In the letter second read above, the Commissioner of Land Administration has reported as follows:-

- (i) Land acquisition is being undertaken to implement various infrastructure projects, with the combined administrative sanction being given for implementing the work / projects as well as for the acquisition of the lands.

- (ii) The lands required for the project vest with the concerned requisitioning departments through the appropriate statutory procedures such as notification u/s 15(1) / 3(1) / 11(1) of the concerned land acquisition Act, and the projects are also underway / completed.
- (iii) However, in many cases the final awards are not passed due to non-availability of funds in the original administrative sanction. Since, the overall fund requirement for the project has increased due to increase in land cost (i.e., in comparison with the originally estimated land cost) as well as the project cost escalation, the revised administrative sanction is warranted.
- (iv) At present, the revised administrative sanction is being taken up in a case-by-case basis in the respective Administrative Departments, for the project as a whole, i.e. for the land cost and the work cost together. This procedure causes undue delay in passing awards and due to this, interest cost @ 12% per annum from the date of notification is accumulated till the date of final award. It is also not just to delay the award and consequent payment of compensation, when the land has already vested with the Government. Further, uncertainty increases due to possible litigation when the project is underway / completed as the actual award has not been passed and land losers often approach Hon'ble Courts, and the same is also viewed negatively by Hon'ble Courts.

2. In order to ease out the above difficulties and reduce the unnecessary financial burden to the State, the Commissioner of Land Administration has suggested the following mechanism to get the revised administrative sanction for the Land Acquisition cost alone.

- a) The Land Acquisition Cost and the Engineering / Project cost may be delinked and a revised administrative sanction for the land acquisition cost alone may be sanctioned separately at the earliest.
- b) The tentative Land Acquisition cost upto the probable date of award may be worked out by the Land Acquisition Officer and presented to the following Sub-Committee in detail, comprising of the following members:-
- i. Secretary to Government, Finance (Expenditure) Department
  - ii. Representative of Additional Chief Secretary to Government, Finance Department
  - iii. Additional / Joint Secretary / Secretary of the concerned Administrative Department
  - iv. Head of Department / Nominee of Requisitioning Department / Agency
  - v. Deputy Secretary (Law)
  - vi. Joint Commissioner of Land Administration (Convenor)

- c) When the above Sub-Committee is satisfied, they may recommend the case of the Steering Committee of Land Acquisition Agency of Tamil Nadu (LAATAN) as already constituted vide Government Order first read above.
- d) Upon approval and recommendation of the above Steering Committee, the concerned Administrative Department may obtain orders directly in calculation for the revised administrative sanction for the land acquisition cost alone.
- e) Further, at the time of the actual revised administrative sanction for the project, the amount as sanctioned above may be adjusted / recognized in the revised administrative sanction.

3. The Government after careful examination of the proposal of the Commissioner of Land Administration, issue orders as follows:-

- a) The Land Acquisition Cost and the Engineering / Project cost shall be delinked and a revised administrative sanction for the land acquisition cost alone be sanctioned separately at the earliest.
- b) The tentative Land Acquisition cost upto the probable date of award shall be worked out by the Land Acquisition Officer and presented to the following Committee in detail, comprising of the following members:-
  - i. Commissioner of Land Administration - Convenor  
(or)
  - ii. Finance Secretary his nominee - Member
  - iii. Secretary of the concerned Administrative Department - Member
  - iv. Head of Department / nominee of the requisitioning department / agency - Member
  - v. Representative of Legal Affairs Secretay - Member
- c) Upon approval and recommendation of the above Committee, the concerned Administrative Department shall obtain orders directly in circulation for the revised administrative sanction for the land acquisition cost alone.
- d) Further, at the time of the actual revised administrative sanction for the project, the amount as sanctioned above shall be adjusted / recognized in the revised administrative sanction.

Accordingly, if any junior official in any of the category of the Engineers who are covered under Common Seniority happens to get promoted either in Public Works Department or in Water Resources Department, the pay level of all persons senior to him/her shall be upgraded with monetary benefit with effect from the date on which his/her junior happens to be promoted by prefixing 'Special' to the upgraded post without any additional responsibilities. As and when the actual turn of the person so upgraded comes in the Department he/she serves, he/she may be accommodated in the promotional post and the post upgraded for him/her shall be downgraded to the pre-existing level."** In the G.O. 2<sup>nd</sup> cited common panel of Executive Engineers are approved and postings were given separately in WRD & PWD. In the G.O. 2<sup>nd</sup> cited, juniors in PWD were promoted as Executive Engineers in PWD and the seniors are promoted in WRD vide G.O. 4<sup>th</sup> cited after 5 months only. We also wish to bring your kind notice that the proposal of Special Executive Engineer posts for seniors in



WRD to be promoted from the date of their juniors promoted as Executive Engineer which was already in the Government is not approved till date.

Meanwhile in the G.O. 5<sup>th</sup> cited Junior Superintending Engineers in PWD where promoted as Chief Engineers in PWD and their Seniors in WRD are to be given Special Chief Engineer with effect from the date of their Junior promotion.

In the G.O. 6<sup>th</sup> cited Junior Executive Engineers in PWD were promoted as Superintending Engineers in PWD and their seniors are to be given Special Superintending Engineer with effect from the date of their Juniors promotion.

Similarly in the G.O. 7<sup>th</sup> cited, Junior Assistant Executive Engineers in PWD were promoted as Executive Engineers in PWD and their seniors are to given Special Executive Engineers with effect from the date of their junior promotion.

We are very much thankful to our Additional Chief Secretary to Government, WRD for taking much effort to give Special Executive Engineer, Special Superintending Engineer and Special Chief Engineer to the seniors in WRD as per the Government order 1<sup>st</sup> cited. However we came to know that the Government orders on the above issue is delayed by Finance & Human Resources Department by raising queries which are against the G.O. 1<sup>st</sup> cited.
