#### Minutes of the 12<sup>th</sup> PEC meeting held on 10.01.2024

The 12<sup>th</sup> combined PEC meeting of AOE and AEA, TNPWD, Chennai-5, was held on 10.01.2024 at the Association Office, Chepauk, Chennai-5 by about 6.15 PM.

Er.S.Gopalakrishnan, President, AOE, Presided the meeting and conducted the proceeding. He invited the General Secretary, AOE to discuss the following subject agenda.

- 1) Recruitment of Assistant Engineers in WRD & PWD Present Stage.
- 2) Promotion Panels in WRD & PWD Present Stage.
- 3) Pay Scale Case Present Stage.
- 4) Conducting General body meeting of our Association Date & Venue to be finalised.
- 5) Accounts for Associations & Poriyaalar Ramalingam Illam Draft for approval.
- 6) Annual report Draft for approval.
- 7) Any other Subjects.

Er.M. Dhanasekaran, General Secretary, AOE briefed the above subject agenda and informed that the verification of certificates for the candidates who got favourable orders in the case filed against recruitment of Assistant Engineers has been started by the TNPSC, requesting the candidates to upload the relevant certificates. #### ORDER:

In Government Order first read above, orders have been issued fixing the estimate of vacancy for the post of Assistant Executive Engineers in Water Resources Department for the year 2023-2024 as "145" Nos.

2. The following SLPs and WPs have been filed in the Supreme Court of India and High Court of Madras with regard to fixation of seniority among Assistant Engineers appointed by direct recruitment and Junior Engineers / Redesignated Assistant Engineers:-

- Engineer, Thiru. Executive Shanthi, **Assistant** Tmt. R. R. Venkatachalam, Assistant Executive Engineer and 6 others and Thiru. K. Vijayakumar, Assistant Executive Engineer and another of Water Resources Department have filed Writ petitions in the High Court of Madras in WP Nos. 21027/2023, 10974/2023 and 25161 of 2023 with a prayer to quash paragraph 9(E) of G.O(Ms) No. 158, Public Works(D2) Department, dated 1.11.2021 and to direct the respondents to get fresh options from petitioners and to allot them accordingly to Public Works Department and consequently to revise the promotions already made pursuant to G.O(2D) No. 23, Public Works(A1) Department, dated 30.8.2022 and issue consequential promotion orders to the eligible petitioners based on their revised options.
- 4. The Hon'ble High Court of Madras in its order third read above has passed the following order:-

"It is hereby clarified that the petitioners herein are aggrieved against their non-promotion to the post of Executive Engineer from the post of Assistant Executive Engineer. While being so, there is no impediment for the respondents to proceed with the promotions to all the other posts except the post of Executive Engineer".

5. In the meanwhile, the Advocate General of Tamil Nadu in his opinion second read above has opined that;

"The temporary promotion under Section 47(1) of the Tamil Nadu Government Servants (Conditions of Service) Act 2016, shall be invoked to save the sufferings of the administration on temporary arrangements till the regular promotion to the posts are made. As observed by the Hon'ble 1st Bench of the Hon'ble High Court of Madras in its judgement dated 17.03.2022 in W.P.No. 35161 of 2019, "The administration may suffer on account of delay in promotion and thus, the arrangement has been provided to fill the posts temporarily from a person possessing qualification prescribed for the posts." Therefore, considering the absence of interim orders in C.A.No. 4372 of 2023, and the large number of vacancies in the post of Assistant Executive Engineer (Civil), I am of the view that the Government may consider giving temporary promotion against the existing vacancies invoking the Section 47(1) of the Tamil Nadu Government Servants (Conditions of Service) Act 2016, subject to the outcome of SLP (Civil) No. 17269 to 17271 of 2022, and C.A. No. 4372 of 2023 cases pending on the file of the Hon'ble Supreme Court of India."

6. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department in his letters fourth read above has sent a proposal to the Government recommending 63 Nos. of the directly appointed Assistant Engineers and 21 Nos. of Junior Engineers / Re-designated Assistant Engineers who are fully eligible to be temporarily promoted / appointed to the post of

Assistant Executive Engineer Water Resources Department under Section 47(1) and 17(1) of Tamil Nadu Government Servant (Conditions of Service) Act, 2016 and requested orders of the Government in this regard. He has also certified that no disciplinary proceedings / criminal cases are pending against the individuals considered for temporary promotion / appointment.

7. The Government after careful examination of the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department in the light of the opinion of the Learned Advocate General of Tamil Nadu have decided to accept it. Accordingly, the Government order temporary promotion to the following 63 Nos. of directly recruited Assistant Engineers and temporary appointment to the following 21 Nos. of Junior Engineers / Re-designated Assistant Engineers in the ratio of 3:1 as Assistant Executive Engineer in Water Resources Department, under Sections 47(1) and 17(1) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 respectively:-
