### **ORDER:**

4. The temporary promotion ordered in paragraph 3 above, shall be subject to the following conditions:-

- Temporary promotion / appointment is granted to the fully qualified persons without assigning any seniority number and it does not confer any right for claiming seniority.
- Persons temporarily promoted / appointed shall be replaced as soon as possible by the member of the service, who is entitled to promotion under the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.
- Persons temporarily promoted / appointed shall not be regarded as a probationer in the higher category or be entitled by reason only of such promotion to any preferential claim to future promotion to such higher category.



- iv. Their service in the post of Assistant Executive Engineer (Electrical) shall be liable to be terminated by the appointing authority at any time without notice and without any reason being assigned under Sections 17(5) and 47(5) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

5. It is certified that the individuals mentioned at paragraph 3 above are fully qualified to hold the post of Assistant Executive Engineer (Electrical) for the purpose of fixation of their pay in the said higher post.
