### **ORDER:**

- (v). Tmt. R.N. Surekha, Executive Engineer, Special Designs Division, Chennai is promoted and posted as Joint Chief Engineer, Designs, Research & Construction Support, Chennai in the existing vacancy.

2. It is certified that the Officers mentioned in paragraph 1 above are fully qualified to hold the promoted post for the purpose of fixation of their pay in the said higher post.

3. The temporary promotions ordered in paragraph 1 above, shall be subject to the following conditions:-

- (i). Persons temporarily promoted shall be replaced as soon as possible by the member of the service, who is entitled to promotion under the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.
- (ii). Persons temporarily promoted shall not be entitled by reason only of such promotion to any preferential claim to future promotion to such higher category.
- (iii). Their service in the post of Superintending Engineer shall be liable to be terminated by the appointing authority at any time without notice and without any reason being assigned, under Section 47(5) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.



4. The Government also direct the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai to send compliance report on the implementation of orders of the promotion and postings ordered above to the Government within 30 days along with copies of assumption of charge in the new station without fail. Any lapse in this regard will be viewed seriously.
