Association of Engineers and Assistant Engineers' Association, TNPWD, Chepauk, Chennai-5


Sub: Notification inviting Nominations for the posts of Central Office Bearers of AOE & AEA, TNPWD, Chepauk, Chennai-5 for the year 2021-23.


1. The General Body meeting of Association of Engineers and Assistant Engineers' Association, Tamil Nadu PWD which met at Chennai on 08.05.2021, have constituted the Chief Election Committee for conducting the Election of the Central Office Bearers of AOE and AEA for the year 2021-2023. Accordingly the notification as hereunder is issued, calling for nominations as per Appendix-I Election Rules of Revised Bye-laws of Association of Engineers and Assistant Engineers' Association, Tamil Nadu PWD approved by the General Body on 14.10.1990 at Madurai, as per approved additions and amendments to the bye-laws made in the CEC held on 16.12.1995 at Dindigul and also by the CEC held on 14.02.1998 at Thanjavur and by the CEC held on 29.01.2011 at Vellore.
2. As per the Election Rules and Regulations in force, the names and number of posts for which elections are to be conducted for the year 2021-2023 for Association of Engineers and Assistant Engineers' Association are furnished in Annexure-I and Annexure-II respectively of this Notification.
3. In conformity with the above Rules and Regulations, nominations are invited from the members of the Association as on 15.08.2021 i.e. current Members of Association who have paid the annual subscription of **Rs.2000/-** for the year 2021 as on 15.08.2021 and Life Members who have paid the Special Subscription of **Rs.1000/-** for the year 2021 as on 15.08.2021 (as per resolution passed in Combined Central Executive Committee Meeting of AOE and AEA held on 17.11.2007 at Madurai) in the standard format (Copy enclosed in Annexure-III) and as per the election schedule specified in Annexure-IV.
4. The following amendments as approved by the Combined C.E.C. held at Thanjavur on 14.02.1998 and based on the CEC on 10.06.2017 at Chennai and based on the General Body meeting on 08.05.2021 at Chennai may please be noted while submitting the nominations to the Chief Election Committee.


Rule 1:	For the post of President and General Secretary of AOE and AEA member contestant shall be proposed by a minimum of 10 members and seconded by another 10 members who are to be spread over atleast in 4 District Branches and the member contestants should have served as an Office Bearer (including E.C. members) either in the Parent Association or in any of the Branches at least two years previously.
Rule 2:	All contesting members for every post in AOE and AEA shall be full-fledged members in the ENGIBEF Phase III/ Phase IV and further shall be members continuously atleast for the immediate preceding two years.
Rule 3:	The Executive Committee Members (5 Nos) to the Association of Engineers and Executive Committee members (10 Nos) to the Assistant Engineers' Association shall be nominated by the newly elected Parent Executive Committee, at its first meeting after assumption of office (hence no election will be held for the Executive Committee Members posts both in Association of Engineers and Assistant Engineers' Association).
Rule 4:	For posts other than President and General Secretary Rule 1 shall not apply, but other conditions stipulated in the Rule 2 above shall apply.
Rule 5:	For the eligibility of voters, all Current Members or Life Members who has paid annual (or) Spl. Subscription upto the day of election.

5. The nomination forms in plain paper duly filled in may please be sent to **Er.D.John**, Joint Chief Election Convenor, Chief Election Committee, AOE and AEA, Tamil Nadu PWD, Chepakkam, Chennai-600 005 in a closed and sealed cover so as to reach him before 6.00 p.m. on 31.08.2021. Any nomination received after the stipulated date and time shall be rejected and the Chief Election Committee shall not be held responsible for the postal delay or loss in transit in this matter. No correspondence shall be entertained in this regard. To avoid such embarrassment, candidates are advised to send / hand over the nominations in person to the Chief Election Committee well in advance.
6. All the Nomination forms received by the Chief Election Committee within the stipulated time and date shall be opened at 6.30 p.m. on 31.08.2021 and listed in the presence of members present at Association Office premises, Chennai. The list of valid nominations will be finalized thereafter and sent to all Branches of AOE and AEA as well as to the contestants on 07.09.2021 by post / email and also will be displayed in the Parent Association Office Chennai.

7. The last date for withdrawal of Nomination: **9th of September 2021 upto 6.00 p.m.**
8. The list of final contestants will be communicated to the Branches as well as to the contestants on 14.09.2021.
9. We request your earnest cooperation in conducting the above election in a fair and free manner in accordance with the Election Rules (Appendix.I).
10. Details / clarifications, if any, sought for from the candidates on their nominations proposed have to be submitted by them within 24 hours to decide on the validity of their nominations. The nominations which do not comply with the eligibility requirements will be rejected. The decision of the Chief Election Committee is final in respect of matters pertaining to Election and no member can question its decision. It is for the kind information to all the members of the Association that the Chief Election Committee will function and act as per the provisions of revised and updated Election Bye-laws of the Association.
- 11. All members are requested to strictly follow the SOP for Covid-19 stipulated by the Government in force during the election process.**


- 1) Separate Consent Letter shall be sent before the last date and time for receipt of Nomination when the consent of the Candidate is not furnished in the Nomination form itself.


