

MINUTES OF THE 13th PEC MEETING HELD ON 22.10.2025 @ AOE & AEA OFFICE PREMISES, CHEPAKKAM, CHENNAI-5

The 13th PEC was conducted at office of AOE & AEA @ Chennai 6.00 PM on 22.10.2025. Er.S.Sundaresan, EC Member, AOE welcomed the Office Bearers for the meeting and asked Er.M.Dhansekaran, General Secretary, AOE to brief the agenda as circulated. The agendas are:

- 1) Pay Case Present status and follow up action.
- 2) Promotion Panels & Postings.
- 3) Conducting General Body Meeting.
- 4) Accounts of AOE, AEA, Legal, ENGIBEF, PRI and Annual Report of AOE & AEA
- 5) Any other Subjects.

Er.M.Dhanasekaran, General Secretary, AOE expressed with regression about the announcement of Government that 25.10.025 as a compensatory working day. Due to such announcement it is inevitable to postpone our General Body Meeting which was scheduled earlier on 25.10.2025 @ Savera Hotel, Chennai.

He also told that, a video conference was conducted with Office Bearers of branches on 19.10.2025 evening, in which all have agreed that the post ponement is unavoidable, and most of Office Bearers have suggested to plan to conduct General Body Meeting after monsoon period.

Er.S.Srinivasan, President, AEA shared that while approaching Hotel management in this regard, they accepted for postponement and requested the early confirmation of alternative dates.

The members of PEC discussed about the suggestion offered Office bearers in Video Conferencing and post the points for discussion such as monsoon, continous holidays, marriage muhurtham dates before finalising the alternate date for General Body Meeting. Further it has been brought to PEC about code of conduct for election and Budget – Session of the Government. After the discussion, it is planned to approach the Hotel management to get available dates in February to finalise the date.

Then Er.K.Stalin, Vice President, AEA, Chennai explained the status of Pay Case, such as the fresh petition is planned to filed at Hon'ble Supreme Court of India in the next month as said earlier to fix time bound for completing Writ Appeal in the High Court of Madras.

Promotional Panel activities:

Er.D.Sivakumar, Treasurer AOE & AEA explained that the name Panel for the post of Assistant Engineer to Assistant Executive Engineer in WRD shall be expected to get approval very soon probably before October 2025. In which it is expected that 46 Nos of Assistant Engineers of 2009 batch may be included.

Er.D.Rajeshwar Babu, Treasurer, ENGIBEF said that the name panel for Executive Engineer in PWD will also be get approval before this month. It is also heard that due to relaxation in service condition the approval of name panel is getting time for approval.

The General Secretary, AOE requested for updating accounts for AOE, AEA, Legal, ENGIBEF and PRI upto Dec 2025 for submitting in GB for approval.

After discussion the following resolution has been passed unanimously:

- Resolved to thank our Minister of WRD, Secretary, WRD and Engineerin-Chief & Chief Engineer (General), WRD for early issue of Promotion order for 22 nos of Assistant Executive Engineer as Executive Engineers in WRD.
- ii. Resolved to postpone the General Body Meeting and planned to conduct in February 2026.
- iii. Resolved to Finalise the date after confirming with Savera Hotel management.
- iv. Resolved to update the accounts upto December 2025 for approval in General Body Meeting.
- v. Resolved to file petition @ Hon'ble Supreme Court of India at earliest to fix time limit for completing writ appeal in High Court.

The meeting concluded with a vote of thanks delivered by **Er.H.Velan**, General Secretary, AEA.

ABSTRACT

Establishment – Water Resources Department - Temporary promotion of Assistant Engineers/ Assistant Engineers appointed by the method of recruitment by transfer as Assistant Executive Engineers under Section 47(1) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016 – Orders – Issued.

- 1. G.O. (D) No.125, Water Resources (A1) Department, dated 29.09.2025.
- From the Engineer-in-Chief and Chief Engineer(General), Water Resources Department, Chennai Letter No.C1(3)/0685/2025, dated 10.10.2025.

ORDER:

In the Government Order first read above, orders have been issued fixing the estimate of vacancy for the post of Assistant Executive Engineers in Water Resources Department for the year 2025-2026 as "101" numbers.

- 2. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai in his letter second read above has stated that the vacancies totaling to 93 in the category of Assistant Executive Engineer have to be filled up on emergent basis in public interest owing to the reason that, the vital on-going projects executed by the Water Resources Department directly benefits public interest, besides emergent monsoon works.
- 3. He has also stated that the total number of 93 vacancies in the post of Assistant Executive Engineer has to be apportioned in the ratio of 3:1 between directly recruited Assistant Engineers/Assistant Engineers appointed by the method of recruitment by transfer and the Junior Engineers/ Redesignated Assistant Engineers respectively, as per Rule 2 (c)(ii) relating to appointment of the Special Rules of the Tamil Nadu Engineering Service. Out of which, 70 vacancies have to be apportioned to the directly recruited Assistant Engineers / Assistant Engineers appointed by transfer and the remaining 23 vacancies have to be apportioned to the Junior Engineers / Redesignated Assistant Engineers. However, none of the Junior Engineers / Redesignated Assistant Engineers have completed 10 years of service as prescribed in the Special Rules for Tamil Nadu Engineering Service for appointment to the post of Assistant Executive Engineer by method of recruitment by transfer. Therefore, the 23 vacancies apportioned under 1 ratio amongst the total number of 93 vacancies in the

post of Assistant Executive Engineer may be reserved due to lack of eligible Junior Engineers / Re-designated Assistant Engineers.

- 4. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has also stated that there is no legal impediment / orders of interim stay / absolute stay / Status—Quo, as on date for temporary promotion to the post of Assistant Executive Engineer on the file of the Hon'ble Madras High Court (including the Madurai Bench) and the Hon'ble Supreme Court of India.
- 5. - 7. The temporary promotion as Assistant Executive Engineer ordered in paragraph 6 above, shall be subject to the following conditions:-
 - Temporary promotion is ordered subject to outcome of W.P.No.3617 of 2017, W.P.No.35161 of 2019, W.P.No.25275 of 2021 and W.P.No.32018 of 2023 pending before the Hon'ble High Court of Madras, Chennai.
 - Temporary promotion is granted to the fully qualified persons without assigning any seniority number and it does not confer any right for claiming seniority.
 - Persons temporarily promoted shall be replaced as soon as possible by the member of the service, who is entitled to promotion under the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.

Sub: Rules – Omission of Rule 56(1)(c) of the Fundamental Rules – Not permitting to retire but retaining in service – Amendments made to the Fundamental Rules, Tamil Nadu Leave Rules and the Tamil Nadu Pension Rules, 1978 – Clarifications and Instructions – Issued

- Ref: 1. Government letter (Ms). No.35/N/2012-1, Personnel and Administrative Reforms (N) Department, dated 03.04.2013.
 - G.O. (Ms). No.81, Human Resources Management (N) Department, dated 04.08.2022.
 - G.O. (Ms). No.111, Human Resources Management (N) Department, dated 11.10.2021.
 - G.O.(Ms).No.47, Human Resources Management (FR-III) Department, dated 29.08.2025.
 - G.O.(Ms).No.192, Finance (Pension) Department, dated 29.08.2025.

The Government recognise that it is of paramount importance that the Government servants who are in service for nearly 25 to 30 years in various capacities and served the public in large should be allowed to retire peacefully. However, there are many instances, where the Government servants have been suspended on the last day of their service or just before their superannuation and not allowed to retire and retained in service under erstwhile F.R.56(1)(c).

2. In this regard, the Hon'ble Chief Minister has made an announcement on the floor of the Legislative Assembly on 07.09.2021 that "suspending the Government servants on the date of their retirement will be avoided". Based on the above said announcement, the Government have issued orders in the Government order third cited to the effect that the disciplinary authorities have to ensure that the suspension orders are not issued on the last date before superannuation of the Government servants.

(P.T.O)

- 3. In order to ensure strict compliance of the aforesaid announcement, the Government had deleted rule 56(1)(c) of the Fundamental Rules so as to allow the Government servants to retire from service peacefully on the date of superannuation itself. Necessary consequential amendments have been issued to the Fundamental Rules and the Tamil Nadu Leave Rules in the Government Order fourth cited and suitable amendments have also been issued to the Tamil Nadu Pension Rules. 1978 in the Government Order fifth cited.
- 4. The consequences of the amendments issued to the said Rules are highlighted below:-
- (1) Rule 56(1)(c) of the Fundamental Rules which enables the appointing authority to retain a Government servant in service beyond the date of his superannuation has been omitted. Hence, hereafter no Government servant can be retained in service beyond the date of their superannuation and they shall be permitted to retire from service on the date of their superannuation.
- (2) Consequently, the disciplinary proceedings for grave charges already initiated and pending against the Government servants cannot be continued under the Tamil Nadu Civil Services (Discipline and Appeal) Rules, 1955, after their retirement, since the said Rules will not apply to the retired Government servants.
- (3) However, the disciplinary proceedings for grave charges pending on the date of retirement against the pensioners to whom the Tamil Nadu Pension Rules, 1978 apply, shall be continued as deemed proceedings under the said Rules. After their retirement and if they are found guilty in the disciplinary proceedings, final orders such as withholding of entire pension or gratuity or both or withdrawal of pension can be passed, if the gravity of the charges warrants such penalty.
- (4) In respect of the Government servants who were appointed into Government service on or after 01.04.2003, the disciplinary proceedings for grave charges pending on the date of their retirement shall be continued as deemed proceedings under F.R.56 (1-B) (provision now inserted in the Fundamental Rules vide Government order 4th cited) after their retirement and if they are found guilty in such disciplinary proceedings, final order withholding of Government contribution to the pension account along with interest of such Government servants either in full or in part can be passed in consultation with Tamil Nadu Public Service Commission.
- (5) If any Government servant appointed into Government service on or after 01.04.2003 has caused pecuniary loss to the Government by any misconduct or negligence, during his service, and is found guilty of such misconduct or negligence in a departmental or judicial proceedings, recovery from the Government contribution of the whole or part can be ordered under the said rule F.R.56 (1-B) to make good the pecuniary loss caused to the Government in consultation with Tamil Nadu Public Service Commission.
- (6) Further, if disciplinary proceedings could not be initiated before the date of superannuation of the Government servant who were appointed on or after 01.04.2003 for any grave misconduct, four year limitation period as prescribed in F.R.56(1-B)(1)(b)(ii) will be attracted.
- (7) In future, in respect of Government servants against whom departmental or judicial proceedings are pending and allowed to retire from service, their terminal benefits have to be disbursed in the manner prescribed in the Annexure-I to this letter.

- (8) As per F.R.56(1-A) (provision now inserted in the Fundamental Rules vide Government order 4th cited) the Government servants who were already retained in service beyond the date of their superannuation under the erstwhile F.R.56(1)(c) shall be deemed to have been retired from service on their respective dates of superannuation and the disciplinary proceedings pending against them shall be continued under rule 9(2)(a) of the Tamil Nadu Pension Rules, 1978 in respect of the pensioners to whom the said Rules apply or under F.R.56 (1-B) in respect of the Government servants who were appointed on or after 01.04.2003.
- 5. In the light of the above amendments, the following clarifications and instructions are issued:-
- (1) Even though as per F.R.56 (1-A), all the Government servants who were not permitted to retire and retained in service under the erstwhile F.R.56(1)(c) as on 29.08.2025 shall be deemed to have been retired from service on their respective dates of superannuation, a formal order permitting them to retire from service with effect from the date of their superannuation shall be issued by the appointing authority concerned in the format prescribed in the Annexure-II to this letter.
- (2) In such cases, terminal benefits of those Government servants have to be settled in such manner as specified in Serial Number 1 of the Annexure-I. In respect of the Government servants who are governed by the Tamil Nadu Pension Rules, 1978 and in receipt of subsistence allowance, necessary proposal to sanction provisional pension shall be sent to the Accountant General immediately without any delay.
- (3) In cases where grave misconduct is alleged to have been committed by the Government servants and they are on the verge of retirement, the disciplinary authorities concerned should complete the disciplinary proceedings as soon as possible and issue final orders thereon before the retirement of such Government servants, so that the delinquents are not spared from the imposition of major penalties they deserve under the Tamil Nadu Civil Services (Discipline and Appeal) Rules, 1955. The time limits prescribed in para 12 of the G.O.(Ms).No.81, Human Resources Management (N) Department, dated.04.08.2022 for processing disciplinary proceedings should be followed scrupulously so as to ensure that there is no unwarranted delay in finalizing them and which is reproduced as follows:-

(i)	To complete the investigation by Directorate of Vigilance and Anti-Corruption and to send a report to Government through Vigilance Commission.	One year
(ii)	To complete the enquiry by the Tribunal and to send its findings to the Department of Secretariat.	One year
(iii)	To pass final orders by the Government/Heads of Department on receipt of the report of the Tribunal.	Four months

- (4) A periodical review of the pending/contemplated disciplinary cases should be undertaken in the following manner:-
 - (a) Once in a year Human Resources Management Department;
 - (b) Once in six months by the Secretariat department concerned;
 - (c) Once in three months Head of the Department concerned;
 - (d) Once in a month District Head concerned.
- (5) The particulars regarding disciplinary proceedings should be uploaded in the IFHRMS portal. An online quarterly periodical of pending disciplinary proceedings shall be furnished by each Head of the Department to the administrative Department of Secretariat concerned during the first week of every quarter and such reports shall be consolidated by each department of Secretariat and furnished to the Human Resources Management (N) Department during the second week of every quarter.
- (6) The appointing authorities should take special attention and ensure that the final orders are issued in the pending disciplinary proceedings against the Government servants who retire before their superannuation.
- (7) Disciplinary action should be taken against the officials responsible for the non-completion of the disciplinary proceedings before the superannuation of the delinquents concerned, due to inordinate delay on their part in processing the disciplinary proceedings.
- 6. All the departments of Secretariat, Heads of Department and all the District Collectors are requested to follow the above said instructions scrupulously without fail and circulate the same to all officers and staff under their control.

Order:

The Government of India, Ministry of Road Transport and Highways in the notification first read above had issued a notification for inserting a Rule 52A in the Central Motor Vehicles Rules, 1989 by which, it has been stipulated that all those Government owned vehicles which are more than 15 years old are to be scrapped and that the registration certificate of the vehicles covered by the Government departments were unilaterally cancelled by the Ministry of Road Transport and Highways with effect from 01.04.2023 through the Vahan portal. Based on the above Notification, the 'renewal of the Certificate of registration' in respect of motor vehicles owned by the State Transport Undertakings and other Public Sector Undertakings expired after the lapse of 15 years from the date of initial registration of the vehicles.

2. In the Government order second read above, orders were issued extending the validity of Registration of 15 years old vehicles and 15 to 20 years old vehicles (on Road) whose Registration Certificate has been cancelled in Parivahan portal and the Transport Commissioner has also been directed to issue an Executive Order permitting the Regional Transport Officers to extend the validity of Registration Certificate upto 30.09.2024 and direct the Regional Transport Officers to issue manual

Fitness Certificate and also allowing collection of the tax for those vehicles and do the renewal of the Fitness Certificate manually.

- 3. In the Government order third read above, orders were issued extending the validity of Registration of 6247 vehicles (on Road) out of 14611 vehicles belonging to Government and Government undertakings, for the further period upto 30.09.2025, whose Registration Certificates to be expired on 01.10.2024.
- 4. In the letter fourth read above, the Transport and Road Safety Commissioner has stated that it is ascertained from the e-mails sent from this office to the Government departments, State Transport Undertakings and Local bodies that about 12000 vehicles validity of registration certificate will expire in due course. The extension given by the Government of Tamil Nadu is expiring on 30.09.2025 and he has also stated that in the meeting held on 20.08.2025 under the Chairmanship of the Additional Chief Secretary to Government, Home Department, Secretariat, Chennai-9, it was decided that the validity of Registration Certificates (RCs) that expired on or after 30.09.2025 be extended upto 30.09.2026 and the Transport Commissioner was requested to submit the proposal on this issue.
- 5. The Transport and Road Safety Commissioner has therefore requested the Government to issue an order directing the Transport Commissioner to issue an Executive Order permitting the RTOs to extend further the validity of Registration Certificates of 12000 vehicles upto 30.09.2026 and to authorize the RTOs to make manual collection of tax and grant /renewal of fitness Certificates in respect of those vehicles which need to be renewed manually, after 01.10.2025, thereof.
- 6. The Government, after careful examination, have decided to accept the proposal of the Transport and Road safety Commissioner to extend the validity of Registration Certificates of 15 years old and 15 to 20 years old vehicles (on Road) and accordingly, direct the Transport Commissioner to issue an Executive Order permitting the Regional Transport Officers to further extend the validity of Registration Certificates of 12000 vehicles belonging to Government Departments, State Transport Undertakings and Local bodies of Tamil Nadu upto 30.09.2026 and to authorise the Regional Transport Officers to issue manual collection of tax and grant /renewal of Fitness Certificates in respect of those vehicles which need to be renewed manually, after 01.10.2025.

Ref: From the Director of Treasuries and Accounts Rc.No.1350591/D2/2025, dated 07.07.2025.

I am to invite your attention to the reference cited, wherein it has been requested to issue clarification on the admissibility of the Additional Charge Allowance based on the sanction order of the competent authority, for the following rules.

- i. FR 49: The additional charge allowance may be sanctioned to the Government servant who hold full additional charge or discharge current duties of any one independent post, either under Government service or under foreign service on deputation in addition to his regular post at one time as a temporary measure.
- ii. FR 49(4): Additional post equivalent to the regular post (ie) when additional charge arrangements are in respect of different jurisdictions, the posts are definitely independent in such cases the additional pay is admissible.

2. In this regard, I am to inform you that as per ruling 5(4) of FR 49, when additional charge arrangements are made in respect of Assistant Engineer in different territorial jurisdiction, the posts are definitely independent, in such cases, the additional pay is admissible. As such, as per the power delegation exercised under FR 49, the Chief Engineer is only empowered to sanction the additional charge allowance in respect of the Assistant Engineer.

Scale of Pay for the post covered in G.O.Ms.No.242, Finance (Pay Cell) Department, dated 22.07.2013 is in dispute since from 2010. After various stages of litigations, at present final order has been delivered by Hon'ble High Court of Madras in WP 20401/2020, dated 04.04.2024.

Regarding Pay Scale, the Government / Finance Secretary has given instruction on 05.01.2023 at the time of hearing, which lost its validity once the Judgment has been delivered on 04.04.2024. In said Judgment it is stated that all the outcome of PGRC 2019 was set aside and instructed the New PGRC-2024 to have fresh analysis over this issue. Till outcome of New PGRC the recommendation of One Man Commission formed in 2010 has to be followed. Moreover, there is no interim order against the Judgment in the appeal filed by the Government.

In this scenario, regarding implementation of Court Order, it is duty of Finance Department to issue fresh instruction which has been raised by Commissioner of Treasury and Accounts and Engineer-in-Chief & Chief Engineer (General), WRD. It is also brought your notice that an instruction was given by Finance (Expenditure) Department dated 14.09.2024, without

knowing the Judgment dated 04.04.2024 where in the instruction, it was ordered to implement the G.O.399 to 410 which was set aside by the Court. This shows that the instructions was given without application of mind.

Because of non-compliance of Court Order and refusing / delaying to issue of fresh instruction, all the categories especially Assistant Engineers, Assistant Executive Engineers and Executive Engineers of our Department are suffered in;

- > The fixation of Pay Scale during promotion
- Daily allowance in Travelling allowance
- Additional Charge allowance
- Selection Grade
- Annual increment

Even after promotion, they are forced to draw lower grade salary by PAO & Treasury which is against natural justice.

During retirement the Engineers (who are in CPS also) are forced to change their pay scale to get retirement benefits, as per set aside G.O.Ms.No.399 which is unethical and warrants contempt of Court.

Engineering Departments are being struggled to maintain departmental co-ordination with Treasuries and PAOs, due to delay in fresh instructions based on Court Order to override the earlier instruction dated 05.01.2023

So, the authority who delays in decision shall be subjected to the action as per Government servants conduct Rule 1973 and Tamil Nadu Government Civil Services (disciplinary and appeal) 2013.

Hence, we request you to issue instructions to respective Finance official for forming fresh PGRC as per instruction of Court order so as to settle the issue at the earliest, and requested to initiate necessary departmental action against officer in-charge Finance Department for not issuing such instructions.

INTEGRATED SYSTEM FOR DESIGN AND DRAWINGS OF HYDRAULIC STRUCTURES FOR IRRIGATION (ISyDDHI)

- Courtesy: Designs Circle and DR&CS, WRD

The Designs Circle, functioning as a Central Design organization of Tamil Nadu Water Resources Department (TNWRD) is responsible for preparing hydraulic designs and drawings for various irrigation structures. Traditionally, the **Design Wing of DRCS, TNWRD** has relied on in-house spreadsheets for hydraulic design and **AutoCAD** for drawing preparation. However, no integrated software is available to combine these functions effectively.

In this context, the Hon'ble Minister for WRD has made Announcements inter alia in the floor of Assembly during the Budget session – Demand for Grant for WRD, on 23.08.2021 that a new dedicated software titled "Integrated System for Design and Drawings of Hydraulic structures for Irrigation (ISyDDHI)" will be developed to improve/ upgrade the existing practice.

The software links field particulars as inputs, carry out analysis, perform design calculations and generate drawings through a user friendly interface. The ownership of this application is with DRCS TNWRD. The DRCS wing will issue construction drawings after checking and vetting with manual design procedures, BIS codes, CWC norms, etc.,

This software system is developed on pilot basis and contains following modules for various hydraulic and soil conditions:

Module 1: Check dam and Anicut.

Module 2: Regulators.

Module 3: Tank weir/ sluice/ bunds/ spillway.

Check dam, Anicut and Regulator:

The longitudinal section & cross section of the river/ drain, hydraulic particulars of the structure to be designed and the materials to be used for each component in the structure is given as input in CSV format.

The software then calculates the Rear Water Level, Front Maximum Water Level, ED arrangements such as stilling basin depth and length, floor thickness, inverted filter, Launching apron and carry out stability analysis of body wall. The stability of abutment, wing walls and return walls are also checked for proposed slope.

The design calculations for the above are generated as CSV file which can be verified with our manual design for any discrepancies. Finally, the AutoCAD drawing is generated by the software automatically which includes Layout, Plan, Cross section, Sectional elevation etc.,

The drawings generated by the software will be comprehensively reviewed to ensure accuracy. This makes the process more rigorous to detect and eliminate any variations as verifications are carried out at three distinct stages: input, design and drawing, thereby enhancing the reliability and quality of the deliverables significantly.

Tank Sluice:

The longitudinal section, cross section, hydraulic particulars of the channel, sluice barrel data and the materials to be used for each component in the structure is given as input in CSV format.

The software then generates design for the barrel, front and rear head wall, wing wall and return walls and generates the required drawing automatically which includes plan, cross sections etc.,

Tank bund:

The hydraulic details, profile and soil properties of the bund is given as input in the designated module of the software. The software then checks the stability of the bund for the most critical section. The stability can also be checked for required sections other than the critical section. The drawing is generated for maximum earth dam section and other sections for various heights.

The benefits of the software are listed below:

- Streamlined, integrated platform replacing spreadsheet–AutoCAD workflow.
- Faster preparation of technically feasible, safe, and economical designs.
- Improved efficiency in issuing drawings for Administrative Sanction.
- Reliable tool supporting field engineers and designers in irrigation projects.
